**GENERAL TERMS & CONDITIONS :**

- 1) The sample of the Paper Wafers (Red Seals) is available for inspection purpose in the Office of the Registrar (Administration), High Court of Bombay, Bench at Aurangabad, on any working day between 10.00 AM. to 5.00 PM. prior to the last date of submission of quotation.
- 2) The Sealed quotations should be addressed to the Registrar (Admn.) High Court of Bombay Bench at Aurangabad, Jalna Road, Aurangabad - 431009.
- 3) The sealed Envelopes should be superscribed with "Quotation for supply of "Paper Wafers (Red Seals)" and must reach to the office of the Registrar (Admn.) High Court of Bombay, Bench at Aurangabad, on or before **19/12/2025 at 5.00 PM.**

- 4) The Rates quoted must be inclusive of all taxes/fright charges etc.
- 5) The bidder should submit the samples of Paper Wafers (Red Seals) along with quotation and also should quote rates per 1000 Nos. and further should **also enclose Photocopies of Shop Registration Certificate, PAN Card and other relevant documents** alongwith the quotation.
- 6) The selected bidder will have to supply the required quantity of the Paper Wafers (Red Seals), as per prescribed size & GSM (as per approved sample by this office) at the office of the Registrar (Admn.)High Court Bench at Aurangabad.
- 7) After delivery of Paper Wafers (Red Seals) or during the period of use [after opening the packets., as required to be opened by the concern Department, if any defect is noticed in the material/Red Wafers/seals or supplied material quality is not as per tender requirement/specifications/sample, the tenderer shall have to take the same [rejected store] back at his own cost and risk, and shall replace such rejected/less material as per sample/ as acceptable to this Registry. The said seals will be taken back by the successful agency at its own cost.
- 8) The time for and the date of delivery of the Red Seals (Wafers) normally maximum 15 days from the date of issue of the purchase order. The tenderer shall deliver all the Red Seals (Wafers) in good condition at the office of Registrar [Admn.], High Court, Aurangabad within the stipulated time.

9) Payment will be made as per Government rule/procedure after successful execution of purchase order, subject to availability of Budget and passing of bill from Treasury. However, it is provided that if there is a delay in making payment of the bill, then this Registry shall not be liable to any interest / charges to the bidder.

10) The High Court of Bombay, Bench at Aurangabad reserves the right to split orders and / or accept or reject any quotation or cancel the tendering process at any stage as also to vary, modify, revise or change any terms and conditions without assigning any reason thereof.

11) The prices quoted by the Vendor shall be in Indian currency and inclusive of all Levis, Taxes introduced by the Government, packaging and delivery charges etc. and not be subject to any price escalation.

12) The decision of the Registry of High Court Bench at Aurangabad in respect of evaluation of bids and /or award of contract shall be final and binding on the Dealer/Supplier which cannot be challenged.

13) Legal dispute, if any, shall be subject to the jurisdiction of Aurangabad Court, at Chhatrapati Sambhajingar.
