The candidates can download their Admit Card in respect of above Screening Test from the official website of Bombay High Court, i.e. <https://bombayhighcourt.nic.in> from Tuesday, 18/02/2025 onwards and should bring the same at the time of Screening Test. Candidates are also directed to read carefully the instructions printed on their Admit Cards and follow them strictly.

The candidates shall take a note that, the enclosed list has been prepared provisionally, as per the information furnished by the candidates in their applications and on verification of their documents received as per the Notice dt. 28/08/2024 which shall be subject to due scrutiny at the time of viva-voce.

Merely because candidates have been allowed to appear for the Screening Test, it shall not be correct to assume that, their candidature for the said post is valid, as the same shall be conditionally depending upon due verification of documents, details of which were furnished by candidates in the application forms, on the basis of originals thereof at the time of viva-voce.
