Advocates and parties in person are requested to follow the following instructions and cooperate.

4) No mentioning is permitted for seeking urgent circulation/ adjournment. In case of only extreme urgent matters that cannot wait till the assigned date shall be taken up on production board. Advocates and parties in person shall submit a praecipe for production of matter with the Court Sheristedar before 10.50 a.m.
