IT IS HEREBY notified for the information of the Advocates and parties that in the Insolvency matters where the adjudication of an individual as an Insolvent is annulled by the Hon'ble Insolvency Court, the practice and procedure followed was that the party concerned is required to lodge a "certified copy" of the Court's Order of annulment with the Official Assignee.
