. These applications are filed seeking direction to respondent to grant the increments to the petitioners. This Court by way of order dated 22.09.2022, in paragraph no.7 specifically made it clear that though the protection was granted by directing that the services of petitioners shall not be terminated, they shall not be entitled to increment without leave of this Court.

2. Learned Senior Advocate Mr. V. D. Sapkal vehemently argued that in similar matters at Bombay and even before this bench, no condition restraining the grant of increment has been imposed. In that view, he submits that applicants are the only persons who have been deprived of getting increments.

3. This Court finds that the orders which are relied upon are the interim orders. However, considering the anxiety of the applicants, place the petitions for final disposal on **24.08.2026** in urgent category. Parties are put to notice that irrespective of the category in which the petitions are listed on the next date, they shall be taken up for final disposal.

4. Since the petitions from the other Benches have also been transferred to this Court, notice of the next date be given well in advance to all the concerned Advocates by pasting a copy of today's order on the conspicuous place of the Bar Rooms at Mumbai, Nagpur, Kolhapur and this Bench.

5. On the next date, only those petitioners who are ready to argue the matters, be heard.

PER COURT :-

1. Today, learned advocate mentions that TET group matters are heard wherein the petitions are filed at Aurangabad. He submits that, the petitions filed at Mumbai, Nagpur and Kolhapur jurisdiction also have been transferred to this Court. However, there was no notice of listing of the TET group matters on the last occasion. Even there is no notice of today's hearing.

2. This Court, in fact, by order dated 03.08.2026 has directed the office to paste the copy of order passed by this Court on conspicuous place of Bar rooms at Mumbai, Nagpur and Kolhapur. However, even now the grievance is made that no notice was properly given.

3. When the matters are transferred to this Court it is expected of the petitioners to engage a lawyer so that listing of the matters can be noticed. In case those are required to be circulated, the same can be immediately done. However, it appears that in many

matters local lawyer is still not engaged. The grievance is now that, other matters also need to be heard along with the present group.

4. Be that as it is, by way of final chance this Court is keeping the group of TET matters on 07.09.2026 at 02.30 p.m.

5. It is made clear that, if, on that day the arguments are not over, the matters will be taken up on 08.09.2026 at 02.30 p.m.

6. Office to again ensure that the order dated 03.08.2026 and today's order is placed on notice board of all the Benches i.e. Principal Seat at Mumbai, Nagpur, Aurangabad and Kolhapur.
