IT IS HEREBY NOTIFIED for the information of the Advocates and the parties appearing in person at **the Principal Seat at Bombay** that the Single Bench presided over by **the Hon'ble Shri Justice N. J. Jamadar** has issued the following directions **with effect from 15<sup>th</sup> September 2025 :**

1. Matters shall be listed as per following schedule : -

1	(A) Civil Writ Petitions of the year 2024 and 2025 (Except assigned to other Courts).	Monday
2	(B) Civil Writ Petitions and Civil Revision Applications against the order of the Civil Courts (Except Rent Act) from the year 2022 onwards.	Tuesday
3	(C) Second Appeals from the year 2022 onwards	Wednesday
4	(D) All Criminal Writ Petitions/Criminal Applications u/s. 482 of Cr. P.C./528 of BNSS from the year 2020 onward, including Bail Applications (Single Bench) arising out of : <ul style="list-style-type: none"> <li>(1) Prevention of Money-Laundering Act; and</li> <li>(2) Investigation by Serious Fraud Investigation Agency</li> <li>(3) Prevention of Corruption Act</li> </ul> (E) Criminal Writ Petitions and Criminal Applications u/s. 482 of Cr.P. C. /528 of BNSS (Single Bench) (except those assigned to other Courts) of the year 2024 and 2025.	Thursday

## **INSTRUCTIONS FOR LISTING OF FRESH MATTERS**

- (A) All fresh matters shall automatically be listed as per assignment and it will come up before the Hon'ble Court after office objections are removed and matter is numbered.
- (B) The listing shall be in the Chronological sequence of their filing under the head "Fresh Matters".
- (C) There is no requirement to mention these matters for listing. Such requests shall not entertained.

## **DIRECTIONS FOR REQUESTING URGENT CIRCULATION ON EMERGENCY**

- (A) To address any felt need for urgent listing of any fresh matter earlier than the above mentioned autolist day, the Advocates or Party-in-person shall state in the praecipe the urgency in brief, with specific reason as to why the petitioner/applicant can not wait till scheduled autolist date. Advocate/Party in Person should mention ACT in praecipe.
- (B) Unless, there is grave urgency necessitating listing of the matter without waiting, there should be no mentioning.
