With due respect, I humbly like to submit that the current Juvenile Justice Board of Dadra and Nagar Haveli have been constituted on 22/01/2020. The tenure of Board has been expired on 21/01/2023 (Copy Enclose).

Also, the tenure of the Selection Committee in the UT of Dadra and Nagar Haveli and Daman & Diu for selection of the Chairperson of Child Welfare Committee and the members of the Child Welfare Committee and member of Juvenile Justice Board, Dadra and Nagar Haveli will be expired on 28/02/2023(Copy Enclosed).

Rule 87 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016 deal with selection Committee and its composition. As per Clause (i) of Sub Rule 1, Rule 87 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016 a retired Judge of High Court is required as the Chairperson to be appointed in consultation with the Chief Justice of the high Court for the Selection Committee.

The UT Administration of Dadra and Nagar Haveli and Daman and Diu come under the jurisdiction on Bombay High Court, Therefore, the Department is requesting to the Hon'ble High Court of Bombay to kindly nominate one retired judge of High Court as the chairperson of the Selection Committee for selection of Chairperson/Member of Child Welfare Committee, member of Juvenile Justice Board for Dadra & Nagar Haveli and Daman & Diu.



The committee shall have tenure of three years and the appointment of members shall be co-terminus with the tenure of the committee. The Selection Committee shall perform its duties as per provisions of Juvenile Justice (Care and Protection of Children) Act 2015 and the Juvenile Justice (Care and Protection of Children) Rules, 2016. The major duties of Selection Committee are detailed as under:-

1. Remuneration of Rs. 10,000/- shall be paid to the Chairperson of the Selection Committee per sitting and also the Chairperson shall be entitled for Travel Allowance (T.A.) and Dearness Allowance.
2. The Selection Committee shall evaluate the candidates on the basis of qualifications, experience of working with children and personal interaction with the candidate.
3. The Selection Committee shall, on the basis of the evaluation procedure and criteria, select and recommend a panel of names in order of merit to the State Government for appointment as Members of the Juvenile Justice Board or Chairperson or Members of the Child Welfare Committee as the case may be.
4. The Selection Committee shall also prepare a list of names for the Child Welfare Committee and Juvenile Justice Board to fill up vacancies, which may arise during the tenure of the Child Welfare Committee and Juvenile Justice Board respectively.
