CORRECTION SLIP TO THE CIVIL MANUAL, 1986

No. P-0704/2000.— In exercise of the powers conferred by Article 227 and Article 235 of the Constitution of the India the Hon'ble the Acting Chief Justice and the Judges of the Bombay High Court is hereby pleased to direct that the following amendments shall be made to the Civil Manual, 1986 :—

Para 742 : Rules and Forms of civil Court's Accounts

(A) Add the following provisions after Clause (a) of Para 742 (8) use of Register 'C' of Chapter XL "Accounts" of the Civil Manual, 1986.

The existing provision of Note to Clause (a) be re-numbered as Note (i)

Insert new provision [Note (ii)] after re-numbered Note (i)

Note : (i) In case of payment of deposit by cheque, the cash receipt shall be entered after the actual realization of the amount of cheque.

(ii) In case of an amount deposited in the Bank Account of the Court by e-payment, the cash receipt shall be entered after the amount is actually credited to the Bank Account of the Court.

(B) The New sub-para (30) be added after the existing paragraph (29) to Paragraph 742 in Chapter XL "Accounts" of the Civil Manual, 1986.

Sub-Para (30) E-payment :

(i) "E-payment" means an amount deposited in the Bank Account of the Court through an electronic medium.

(ii) Provisions of 742 (22) shall not be applicable to the payments made by e-payment after the Office hours.

(iii) Where a payment is made by e-payment after office hours, the entry of such transactions shall be taken in the Register "C", "G", Cash Book (Form I) and Ledger (Form J) on the next working day.

(iv) The Nazir or the officer authorized shall deposit the amount received by e-payment in the Treasury as per the scroll issued by the Bank not later than the next working day.
