3. No mentioning will be allowed for Circulation at 11:00 a.m., 2:00 p.m., 3:00 p.m. and/or 5:00 p.m. by any Advocate /Senior Counsel in Court.
4. Senior Counsel should not mention any matter.
5. Mentioning at 11:00 a.m. would be permitted only if extreme urgency is made out which cannot wait till date given.
6. **Advocates are requested to give appearance only in typed format. No appearance will be recorded if not given in typed format nor speaking to the minutes will be entertained on this count for hand written appearance.**
