

- 1) Await detailed Notification of the postings, which will follow.
- 2) The Hon'ble the Chief Justice and Hon'ble Administrative Judges have been pleased to direct that all the Officers under orders of Annual General Transfers should leave the charge of their present posting in consultation with the Principal District Judges of the respective stations, leave charge during vacation period in such a manner that after utilizing admissible joining period, they shall take charge at new station on the date of re-opening before office hours. This is necessary to ensure that on reopening of Courts after vacation, all the Judicial Officers are functional at new station.
- 3) Except above, all the representations are rejected / filed.
- 4) Courts reopen after vacation on 9<sup>th</sup> June, 2025.
- 5) The Judicial Officers under order of transfer are informed that, hereafter, representations preferred by them against the final Memo of AGT – 2025, will not be entertained unless the Judicial Officers take charge of their new postings.
- 6) The Judicial Officers who are under order of transfer are directed (a) to finish by judgments all cases in which hearing has already been concluded and (b) should endeavour to dispose of all part-heard cases before handing over charge.
- 7) (\*) The transfers made on the request of the Judicial Officers, who were "Not Due" for transfer in AGT – 2025 and whose representations are allowed, are not entitled to claim T.A. / D.A. and Transfer Allowance.
