The above applicants are also directed to note that they will be issued the Hall Tickets with Seat Numbers only after verification and confirmation of their SBI Collect payment made against their online application. Therefore, before approaching the examination center, the applicants must ensure about confirmation / success of their payment of application fees so paid by them through SBI Collect facility against their Registration ID.

## **- General instructions to the candidates -**

1. Candidates shall remain present for Shorthand Dictation Test on the scheduled date before given Reporting time. No candidates would be allowed entry in the examination hall after Reporting time. No request for change of date of test and/or time will be entertained.
2. Change of scheduled time of examination will not be permitted, under any circumstances.
3. Candidates shall bring and produce this Admit Card at the time of the Test. Production of this Admit Card is mandatory, else candidates will not be allowed to appear for the test. In addition to the Hall Ticket, every candidate will have to bring either of the following document such as Photo Identity Proof, e.g. Aadhaar Card, PAN Card, Driving License, Voter Card or alike identification proof to prove their identity.
4. In case of change of name, the candidates are required to bring Gazette/ Marriage Certificate etc. or any other relevant document in support thereof alongwith Hall Ticket.
5. Candidate will be permitted to carry only the following items with them into the examination hall.
  - a) Personal transparent water bottle.
  - b) A simple transparent Ball Point Pen or Pencil.
  - c) Hall Ticket.
  - d) Original Photo Identity Proof (mentioned in point no. 3).
6. No candidates would be allowed to leave the examination hall, on any count, during the examination period.
7. Candidates should not mention any identification mark like \* @ # \$ ! Shri etc. anywhere on the dictation/ transcription/ typing sheet.
8. Carrying, possessing, using and/or transferring any information through any electronic device, such as, a mobile phone, smart watch, digital watch, micro phone, bluetooth instrument, camera, pager, etc., in the examination hall, is strictly prohibited.
9. If candidates bring with them any book, notes or scribbled paper or speak to or communicate with, any other candidates, by any mode, while the examination is going on or smuggles in or takes out the transcription/typing sheet, attempted or unattempted, the Chief Conductor may, upon being informed by the Supervisor, instantly issue suitable order for necessary action, including immediate expulsion from the examination hall.

10. Candidates who disobey the instructions given by the Supervisor or who are guilty of rude or disobedient behaviour, are liable to be instantly expelled from the examination hall.

11. As regards “unfair means”, if any, adopted by candidates during examination, the decision of the Hon'ble Selection Committee shall be binding, upon the candidates.

12. Candidates are advised to visit website i.e. <https://bombayhighcourt.nic.in> for result of the Shorthand Dictation Test. No separate communication will be made to any individual.

13. Candidates who passed in Shorthand Dictation Test will only be called for Typing Test.

14. Eligibility of candidates will be finally decided after scrutiny of the information furnished in the applications, verification of documents and testimonials at the time of viva-voce.

15. The decision of the Hon'ble Selection Committee, on any issue relating to Shorthand Dictation Test, shall be final and binding upon all the candidates.

**16. Candidates should keep their personal belongings (if any) outside the Examination Center, at their own risk.**

**17. Candidates should strictly adhere to the aforesaid instructions.**
