The empanelment for supply of books will be governed by the following terms and conditions: -

1. The High Court of Bombay, Bench at Aurangabad, reserves the right to change or modify or amend or substitute any clause(s) in the "Terms and conditions", if required at any time.
2. The Registry reserves the right to empanel any vendor and to cancel the empanelment at any time, without assigning any notice or reason.
3. Submission of the application does not confer any right on any applicants for empanelment with this Registry.
4. The decision of this Registry on all the matters connected with or incidental to empanelment shall be final and binding on all and shall not be called in question on any ground.
5. The Registry does not bind to place the purchase order to the approved vendor and reserves the right to purchase any material from any other vendor who is not empanelled with it.
6. The library will place purchase orders with the empanelled vendors who offer best and prompt services and will try to distribute the purchase orders equally amongst the vendors.
7. It is mandatory to the empanelled vendors to supply the books in a short notice of 24 hours or lesser time as per the urgency of the Court.
8. The purchase of books (Print and electronic) for the library will not be bulk purchase but regular purchase with limited number of copies as and when required throughout the year, the vendors will have to send the books on approval basis to the library and collect back the books which are not approved, at their own cost.
9. Payment of the bills towards supply of books will be made on the availability of funds from the Government. However for this reason supply of books should not suffer.
10. The applicant should clearly mention the items for which they seek empanelment along with maximum discount offered by them for the purchase of Print/Electronic form of law book, Bare Acts, General Books, Law Reports etc. The maximum discount rate once offered by a vendor/publisher cannot be reduced during the

period of empanelment.

11. The panel of vendors approved for particular items will be valid for a period of two year (2025-26 and 2026-27) with effect from the date of empanelment till 31st March, 2027.
12. For supply of foreign books only authorised distributors/agents of publishers/ distributors will be entertained for empanelment. GOC (Good Office Committee) will be applicable.
13. The supplier will have to submit a Demand Draft of Rs. 3600/- [Non-refundable] as a tender fees and also to submit a Demand Draft for Rs. 18000/-, as an EMD [refundable] drawn on any Nationalized Bank, in favour of the Registry [Admn.], High Court, Aurangabad alongwith the quotation. The EMD will be return to the unsuccessful agencies, upon receipt of written request and also, to the selected supplier/s, after the submission of bank guarantee. The Suppliers having Registration under MSME are exempted from paying Tender Form Fees and Earnest Money Deposits.
14. The Vendors/Suppliers should Pay ` **10,000/- (Rs. Ten thousand only)** as a **Security Deposit** in the form of Bank guarantee of any Nationalized Bank, after receipt of the tender acceptance letter from this office which will be refundable after successful completion of the contract period. If, successful bidder is breach of any of terms and conditions or fail to provide express service during the contract period then the registry reserve the right to forfeit the said Bank Guarantee. The respective Supplier/Vendor has to submit the request application for refund of Security Deposit only after the contract period is over.
15. The tender of the vendor/ bookseller offering highest rate of discount will be approved in piecemeal as regards particular publication to that extent.
16. On approval of the Books/ publications by this office, the complete supply as per demand would be compulsory.
17. The vendors are bound to make replacement of the book in the event any defect is found/traced at any point of time
18. The book supplier/vendor who repeatedly fails to make the complete supply of the books, the name of said firm will be removed from the list of booksellers of this office.

19. It will be mandatory for the successful vendor to supply books within 15 days from the receipt of order.
20. The High Court of Bombay Bench at Aurangabad reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to award of contract, cancel the tendering process at any stage without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for Tendering Authority's action.
